

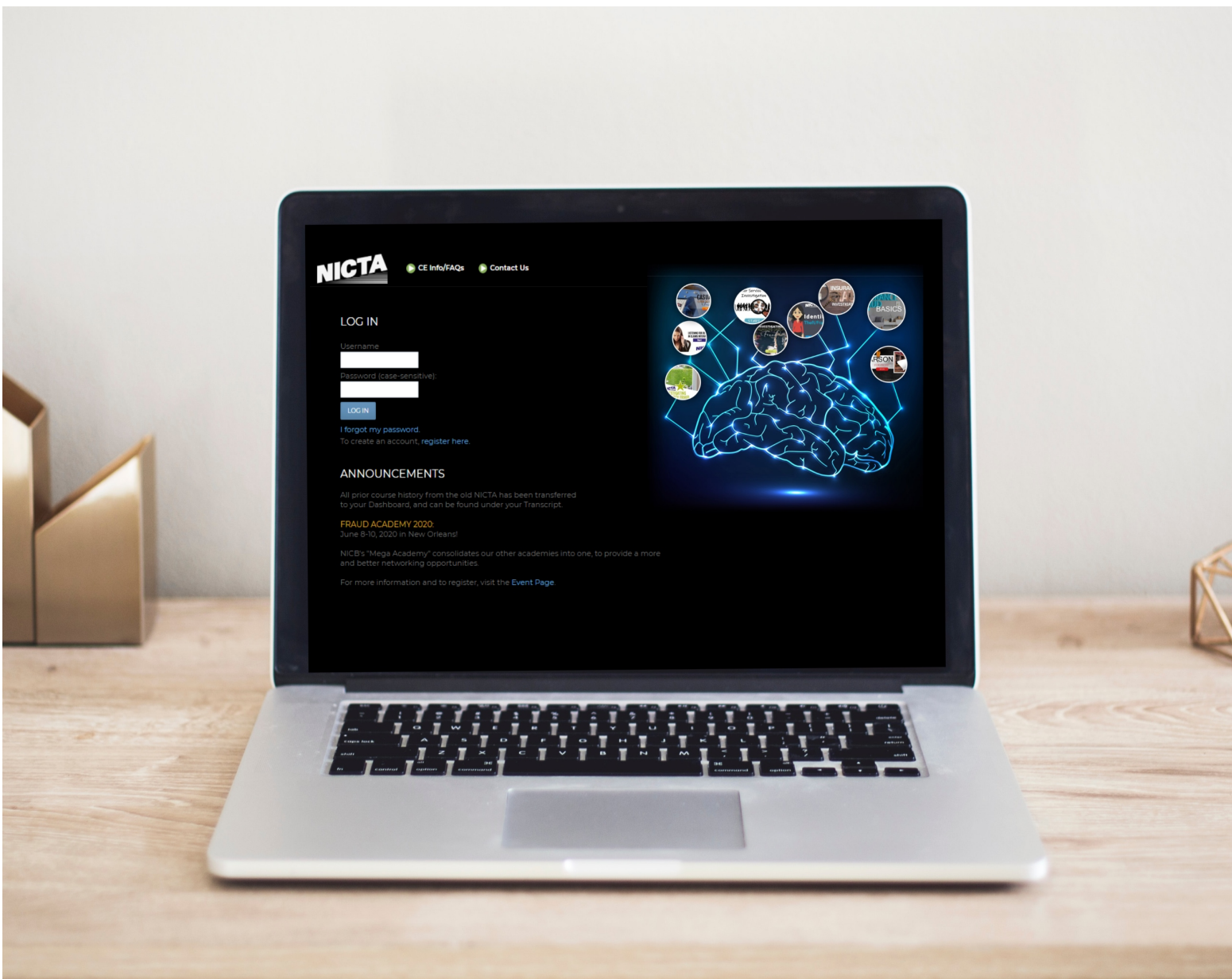

NICTA is an online resource that delivers training and resources for insurance personnel, law enforcement and the public through online course-ware using rich media to enhance a user's training experience.



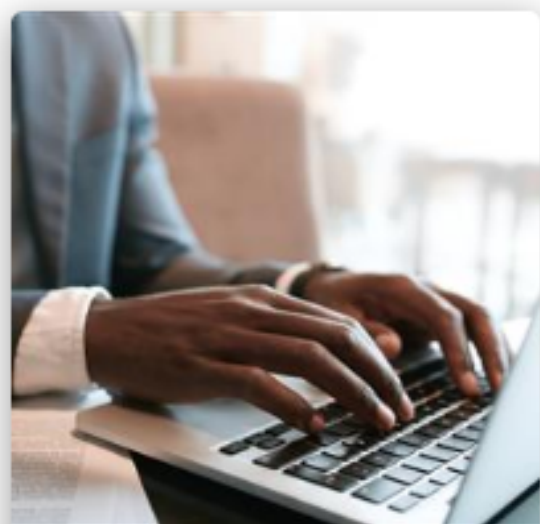
