

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the FastPitchRecruits.com and FastPitchRecruits.com and Real Time Athletes and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to FastPitchRecruits.com and Real Time Athletes include FastPitchRecruits.com, FPR/RTA, OnDeck Measurements and ondeckmeasurements.com. The FPR/RTA website is a Athletic Recruiting and Testing site. By using the FPR/RTA website, you consent to the data practices described in this statement.

TRUSTe Privacy Program

FPR/RTA is a licensee of the TRUSTe Privacy Program. TRUSTe is an independent organization whose mission is to build users' trust and confidence in the Internet by promoting the use of fair information practices. Because we want to demonstrate our commitment to your privacy, we have agreed to disclose our information practices and have our privacy practices reviewed for compliance by TRUSTe.

Collection of your Personal Information

FPR/RTA may collect personally identifiable information, such as your name. If you purchase FPR/RTA's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. FPR/RTA may also collect anonymous demographic information, which is not unique to you, such as your age, gender and hometown, high school, gpa. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by FPR/RTA. Use of your Personal Information

FPR/RTA collects and uses your personal information to operate its website(s) and deliver the services you have requested.

FPR/RTA may also use your personally identifiable information to inform you of other products or services available from FPR/RTA and its affiliates. FPR/RTA may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

FPR/RTA does not sell, rent or lease its customer lists to third parties.

FPR/RTA may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. FPR/RTA may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to FPR/RTA, and they are required to maintain the confidentiality of your information.

FPR/RTA may keep track of the websites and pages our users visit within FPR/RTA, in order to determine what FPR/RTA services are the most popular. FPR/RTA will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on FPR/RTA or the site; (b) protect and defend the rights or property of FPR/RTA; and, (c) act under exigent circumstances to protect the personal safety of users of FPR/RTA, or the public.

Use of Cookies

The FPR/RTA website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize FPR/RTA pages, or register with FPR/RTA site or services, a cookie helps FPR/RTA to recall your specific information on subsequent visits.
