In compliance with Act 16 of 1929 (MCL 483.1 et seq.), the Landowner(s) is/are hereby advised as follows:

- (a) The anticipated physical impact of the pipeline construction on the Landowner's Property is as follows: The right-of-way and easement, temporary work space and additional temporary work space (hereinafter collectively called "Work Zone") will be excavated to allow for the installation of a pipeline (hereinafter called "Work"). After the Work is completed, the Work Zone will be returned to essentially a pre-construction condition.
- (b) You are hereby provided written assurance that any agricultural drainage tile that is damaged or removed during the Work will be repaired or replaced to preconstruction working condition. As used in this Notice, "drainage tile" includes any surface or subsurface system by which the movement of water is redirected.
- (c) You are hereby provided written assurance that topsoil that is disturbed in the Work Zone will be properly separated and replaced. As used in this Notice, "topsoil" means surface soil that is presumed to be fertile as distinguished from subsoil.
- (d) You are hereby notified that in the event an appraisal is prepared, a "before and after" appraisal method will be used.
- (e) The following is an estimated value of the crop loss in the Work Zone for 250% overall property used to produce annual crops prior to the Work. The estimate is based on the historic crop yield of the property before the Work. The Landowner shall provide historic crop yield values upon request. The estimated crop loss value in the Work Zone is _____.

This estimated crop loss value was calculated as the sum of the percentage of the estimated crop losses for the years as follows
2012 at 100% = _____ + 2013 at 75% = _____ + 2014 at 50% = _____ + 2015 at 25% = _____.

- (f) Notice is hereby provided that Enbridge Energy, Limited Partnership will make payment for all damages incurred after construction of the pipeline due to the pipeline owner's or operator's entry upon the Property to exercise easement rights, except that the owner or operator of the pipeline is allowed to maintain a clear right-of-way without further compensation being due to the Landowner.
- (g) A Landowner has rights under of the Uniform Condemnation Procedures Act, 1980 PA 87, MCL 213.51 – 213.77 (hereinafter called "UCPA") and a copy of the UCPA is being provided to the Landowner(s) along with this Notice.
- (h) The information in this Notice is included with any offer to the Landowner(s) for an easement for the purpose of locating, constructing, maintaining, operating, and transporting crude oil or petroleum pipelines on agricultural property.
